

APA 6 Quick Guide: Reference List

Rules

A basic APA reference entry is made up of the following parts:

AUTHOR + YEAR + TITLE+ PUBLISHER INFORMATION OR DOI OR RETRIEVED FROM URL

There are slight variations for different sources. The most common ones are shown below. For more examples, visit the FedCite Referencing website here: https://federation.edu.au/library/fedcite.

BOOK, PRINT: Author, Initial. (Year). Title: Subtitle, (# ed., Vol. #). City, State/County: Publisher.

Basic print book: Winton, T. (2001). Dirt music. Sydney, Australia: Picador.

Chapter from edited collection: Brown, J. (2001). Silence, taboo and infectious disease. In A. Mills & J. Smith (Eds), *Utter silence*: *Voicing the unspeakable*, (pp. 83-91). New York, NY: Peter Lang.

Library e-book: Hampden-Turner, C., & Trompenaars, A. (2000). *Building cross-cultural competence:* How to create wealth from conflicting values. Available from http://search.ebscohost.com/

JOURNAL ARTICLE: Author, Initial. (Year). Article title. Journal Name, vol(issue), xx-xx. DOI or URL

Print or online with doi: Krueger, W. S., & Gray, G. C. (2013). Swine influenza virus infections in man. *Current Topics in Microbiology and Immunology*, 370, 201-225. doi: 10.1007/82_2012_268

Online with URL (no doi): Moran, W. (2014). Enhancing understanding of teaching and the profession through school innovation rounds. *Australian Journal of Teacher Education*, *39*(3), 68-85. Retrieved from http://ro.ecu.edu.au/ajte/

WEBSITE: Author, Initial. (Year, Month Day [if available]). Title [form, if needed]. Retrieved Month Day, Year, from URL

WEBSITE PDF: Author, Initial (Year). Title. DOI or Retrieved from URL

City of Ballarat. (2011). *Annual report*. Retrieved from http://www.ballarat.vic.gov.au/media/499612/annual%20reportcomplete.pdf

Formatting

- Start on a new page at the end of your work, with the heading 'References' centred (same font size and style as the rest of the text).
- Double line-space your reference list. (Remove any additional 'Before or After paragraph' line spaces)
- If a DOI or URL needs to be broken, break before a slash or a punctuation mark.
- Hyperlinks must be removed by right-clicking on the hyperlink, then clicking 'Remove hyperlink'
- Capitalise entries using *Sentence case* for all entries (except journal titles, proper nouns, prepositions and conjunctions). Sentence case capitalises only the first letter of the sentence.



Include

One reference list entry for every source you have cited in the text. Do <u>not</u> add entries for material you have not cited in your work.

Arranging the entries

- Arrange all entries in alphabetical order by the surname of the first author or title. Arrange alphabetically letter-by-letter, including prefixes M, Mc and Mac (i.e., M, then Mac, then Mc).
- If you have more than one entry with the same author, list by year (earliest first).
- If you have multiple sources with the same author as writer/co-writers, any single author entries precede multiple-author entries with the same initial surname (i.e., Jones, 1999 is listed before Jones and Harris, 2001).
- If you have more than one entry with same author/s and year, list alphabetically by title, and add a lower case letter to each year; e.g., 'a' for first, 'b' for second, etc.`
